1.1 These terms of use, together with the Privacy Policy and GDPR Policy (collectively, the "Terms of Use") set out the terms on which Kinchel Sociedad Anónima, DBA Dynamic DMC Costa Rica, a Costa Rican corporation and Panaidea Sociedad Anónima DBA Dynamic DMC Panama, a Panamanian corporation (together with certain specified affiliates and subsidiaries: "Dynamic", "Dynamic DMC", "we", "us, "our") provides services (the "Services") through Dynamic DMC's booking platform through may be made (the "Platform") as available our website (www.dynamicstore.com, together with all related domains, white label and affiliate sites, mobile properties and related applications, collectively referred to as the "Website") and over the telephone. When we refer to "you", we mean any person that accesses or uses the Services. Dynamic DMC is not a travel or tour agency, nor is it a supplier of tours, activities or experiences. When you make a booking, you are using the Platform to contract with third party suppliers.

1.3 These Terms of Use govern your relationship with us in respect of your use of the Services, including any bookings that you make of any tour, ticket, attraction, activity and/or experience (described in these Terms of Use as an "Experience") that is advertised on the Website and is made available by a third party supplier (each, a "Product").

1.4 By using or accessing the Services, by booking a Product ("Book", "Booking"), and/or creating a selection of experiences at the Website (a "Program Account"), you agree to be bound by these Terms of Use without modification, and you represent that you have read and understood them. In all Booking arrangements, the person making the Booking shall be deemed to have accepted these Terms of Use on behalf of all the persons named in the Booking.

1.5 We may update or otherwise modify these Terms of Use at any time, and you understand and agree that your continued access or use of the Services after such change signifies your acceptance of the updated Terms of Use. We will note the date that updates were last made to the Terms of Use at the top of this page, and the updated Terms of Use will take effect upon posting. It is your responsibility to return to this page periodically to review the most current version of the Terms of Use.

### Use of the Services

2.1 As a condition of your use of the Services, you represent and warrant that (i) all information supplied by you in the course of your use of the Services is true, accurate, current and complete, and (ii) you are 13 years of age or older in order to use the Website. Dynamic does not knowingly collect the information of anyone under the age of 13.

2.3 You further represent and warrant that you (a) are not currently suspended and have not previously been banned by Dynamic DMC from using the Services; (b) are not acting on behalf of a competitor of Dynamic DMC; (c) will not create more than one Program Account; and (d) have full power and authority to enter into this legally binding agreement and in doing so will not violate any other agreement to which you are a party.

2.4 We retain the right at our sole discretion to deny access to the Services to anyone at any time and for any reason, including, but not limited to, for violation of these Terms of Use.

6.1. 11.1 The price of each Product will be quoted on a per-person basis, unless otherwise specified.

11.2 For Experiences being bought in Panama, the rates are based on the local Panamanian Balboa, with a exchange rate that equals US\$1.00 = B/. \$1.00. In Costa Rica prices are based on the local tariff at the time of quoting, converted at the prevailing foreign-exchange rate as determined by Banco Central De Costa Rica. See Section 12 for more information about currency conversions.

11.3 Price quotations are subject to change without notice, until a Booking has been made.

11.4 Unless the Supplier has otherwise specified, prices do not include any local taxes or use-fees, including foreign departure, security, port charges, park fees, customs, immigration, agricultural, passenger-facility charges or international transportation tax.

11.5 Inclusions are determined by the Supplier. Prices do not include tips/gratuities; passport and visa fees; baggage and personal insurance; any items of a personal nature; taxes or duties; and any beverages or food that the Supplier has not specifically stated are included.

# **Currency Conversions**

12.1 If Dynamic DMC will always provide its prices in United States of America Dollars (USD), currency exchange rates in Costa Rica are based on the Banco Central de Costa Rica that are available online daily and should be used as guidelines. Rates are not verified, and actual rates may vary. Currency quotes may not be updated on a daily basis, and Dynamic DMC and its affiliates do not warrant or guarantee accuracy. Dynamic DMC shall not be liable to you if prices change due to currency fluctuations.

#### Payments

13.1 When you make a Booking, Dynamic DMC, as the limited payment collection agent of the Supplier, collects your payment information and processes your payment as described in Section 14. Full payment by credit or debit card is required to make a Booking, unless otherwise specified. The pfayee will be listed as DYNAMICDMC on your statement.

13.2 The value of your Booking may be subject to taxes, duties, foreign transaction, currency exchange or other fees. Your bank or payment card company may convert the payment into the local currency and may charge fees, resulting in differences between the amount displayed through the Platform, and the final amount charged to you. Dynamic DMC recommends that you contact your bank or card company if you have any questions concerning any applicable currency conversion or fees.

### Payment Processing

14.1 Under these Terms of Use, the payment processing services for the Services provided are provided by Kinchel Sociedad Anónima (on behalf of Dynamic DMC Costa Rica) and Panaidea Sociedad Anónima (on behalf of Dynamic DMC Panama). And Panaidea Sociedad Anónima's registered office address is 43 East Street, Bella Vista, Panama City, Panama.

### Modifications or Cancellations by You

15.1 Once a Product has been purchased, your Booking cannot be changed by you or cancelled with a refund, unless otherwise stated in the terms and conditions applicable to such Product.

15.2 The standard cancellation policy allows you to request a change to and/or cancel a Booking up until 48 hours before the start time of the Booking; or if the Experience does not have an explicit start time, the deadline to request a change or to cancel will generally be 11:59pm, two days before the start date. Timings are calculated in accordance with the time zone of the Experience.

15.3 If any Product is designated as 'All Sales Final' or with materially similar messaging (which includes but is not limited to all group bookings booked through our Group Bookings Department), it is non-refundable, and it will not be possible to change or cancel it after making a Booking. A minority of Products have other, different cancellation policies. In all circumstances, you must check the cancellation policy contained in the applicable Product listing at the time of your Booking, which is the policy that will apply to and govern the terms of your cancellation and any refunds.
